This document is intended for the use of Agilent Service Centers and by self-maintaining customers.

- Section 1 Getting Started: This section provides the standard procedure for reception and installation of the module (software and hardware) as a prerequisite for conducting the following tests.
- Section 2 Module Test Procedure: Details the automated N7800 TME test procedures which will determine if the module is function correctly and within specification.
- Section 3 Service Operations: Provides information on replacement parts and module core replacement procedure.
- Appendix Reference: Provides a brief technical overview of the module.

Related Documentation

In addition to this Service Guide, other documentation for the M9202A includes:

- Startup Guide: Provides instructions to unpack, inspect, install and verify operation of the module. The key elements from this Startup Guide are duplicated in the Getting Started section of this document.
- Data Sheet : Provides product overview and detailed specifications for the digitizer.
- User Guide and Soft Front Panel (SFP) help system : An HTML Help (.chm) based system which provides information on the complete range of modular digitizer products, and information on the use of the Soft Front Panel applications and other utilities.
- **IVI Driver reference (help system) :** An HTML Help system covering the MD1 IVI-C and IVI-COM driver in detail, intended as a programmers reference.
- LabVIEW Driver reference (help system) : An HTML Help system covering the use of the supplied Lab-VIEW driver package. A useful reference for programmers.

All of the product documentation listed above is included on the CD shipped with your module. If you have previously run the product software installer on your PC you may access the documentation directly from the Windows Start Menu, *Start > All Programs > Agilent > MD1 >*, except for the IVI help which is located at *Start > All Programs > Agilent IVI Drivers > AgMD1 Digitizer >*.

Step 1: Unpack and Inspect the Module

CAUTION The module is shipped in materials which prevent damage from static. The module should only be removed from the packaging in an anti-static area ensuring that correct anti-static precautions are taken. Store all modules in anti-static envelopes when not in use.

Inspect for damage

After unpacking the module, carefully inspect it for any shipping damage. Report any damage to the shipping agent immediately, as such damage is not covered by the warranty.

CAUTION To avoid damage when handling a module, do not touch exposed connector pins.

ESD Precautions



Electrostatic discharge (ESD) can damage or destroy electronic components. Use a static-safe work station to perform all work on electronic assemblies. The figure (left) shows a static-safe work station using two types of ESD protection: conductive table-mat and wrist-strap combination, and conductive floor-mat and heel-strap combination. Both types, when used together, provide a significant level of ESD protection. Of the two, only the table-mat and wrist-strap combination provides adequate ESD protection when used alone. To ensure user safety, the static-safe accessories must provide at least 1 M Ω of isolation from ground.

Power up the Controller

If you are using a remote controller, power up the host computer.

If you are using an embedded controller, complete the following steps:

- 1. Install the embedded controller module into the compatible chassis (Agilent M9018A chassis recommended).
- 2. Connect peripherals (mouse, keyboard, monitor).
- 3. Power up the chassis.

Install the Software

The module software is located on the Agilent MD1 High-Speed Digitizer Software and Product Information CD CD (M9210-90007) and the Agilent IO Library Suite CD (E2904-60003). This software is also available for download at the Agilent website www.agilent.com/find/PXI-Digitizers

NOTE Administrator privileges will be needed for software and hardware installation. This includes the case of first-time installation of a module in a different crate slot.

This installation includes the following:

• Agilent IO Library Suite (IOLS), which includes the Agilent Connection Expert. This software must be installed first.

NOTE Version 16.2 (or newer) of the Agilent IO Libraries Suite is required.

- Soft Front Panel (SFP), device drivers (IVI-C, IVI-COM, and LabVIEW G) for all modules.
- 1. From the Agilent IOLS CD (E2904-60003) browser launch the installer.
- 2. Follow the installer prompts to install the IO Library Suite.
- 3. From the Agilent MD1 High-Speed Digitizer Software and Product Information CD CD (M9210-90007) launch the installer.
- 4. Follow the installer prompts to install all software and documentation.
- 5. After installation is complete, re-start the chassis and the host PC if you are using a remote controller.

Step 3: Install the Module

CAUTION PXI hardware does not support "hot-swap" operation. Before installing the module into the chassis, power off the chassis to prevent damage to the module.



The module can be installed in any PXIe slot marked with a peripheral slot compatibility image (a circle containing the slot number).



- 1. Make sure the chassis is connected to the main supply, but power switch is in the Off (Standby) position.
- 2. If the chassis has multiple fan speed settings, ensure that the fans are set to automatic. Do not set the fan speed to low or turn it off.
- 3. Position the chassis so that there is ample space between the chassis fan intake and exhaust vents.
- 4. If using a remote controller, install the System Interface Card in the slot identified by the triangle symbol: 4
- 5. Install the module into the appropriate slot of the chassis by placing the module card edges into the front module guides (top and bottom), Ensure that the ejector handle is pushed down and slide it to the rear.
- 6. When resistance is felt, latch the module by pulling up on the ejector handle.

- 7. Tighten the screws on the module front panel. Performance may suffer if the screws are not tightened.
- 8. Verify that the chassis fans are operable and free of dust and other contaminants that may restrict airflow.
- 9. Install all chassis covers and filler panels after installing the module. Missing filler panels may disrupt necessary air circulation in the chassis.
- 10. Plug in and power up the PXI chassis. (If you are using a remote controller, reboot the host PC.)
- 11. Check the status LED on the module front panel, It should be orange or red when the power is applied, If notthere is a problem with either the module or the chassis.
- 12. Follow the New Hardware Wizard's instructions to install the driver.
- 13. Reboot the system.

Section 2 - Performance Verification and Adjustment

Performance Verification for the is performed using the Agilent Test Management Environment (N7800 TME) software.

If it is not already installed on your PC, download and install the Agilent N7800A Test Management Environment Software from the TME website: <u>http://calsw.tm.agilent.com/</u> Refer to the 'Readme' and Help documents on that page.

The specific application for testing the M9202Ais N7871A Calibration Application for IF Digitizers, which may also be found on the TME webpage.

If you have already installed the N7800A software, the documentation will have been installed to your PC, and may be found as follows:

- Open the 'Start Menu' > 'All Programs' > 'Agilent Test Management Environment'
- Chose one of the documents:
 - 'Help for the Agilent N7871A IF Digitizer Calibration Application', or
 - 'Readme for the Agilent N7871A IF Digitizer Calibration Application'

Or if you have not yet installed the software, it may be found on the web page listed above.

If the module passes the test:

The module may be returned to the user. Please follow your internal 'No Fault Found' procedure.

If the module fails the test

There is only one adjustment available on the M9202A via the N7871A utility, this is 'AC Gain Accuracy'. If the failure is related to 'AC Gain Accuracy' it may be possible to adjust this parameter and retest the module. Please refer to the N7871A Help for further information.

If the failure is not related to 'AC Gain Accuracy', or the module continues to fail the test after adjustment then module must be replaced using the 'Core Replacement' procedure. Refer to to Section 3 of this document.

Section 3 - Service Procedures

This section lists the replacement parts available for the M9202A PXI Express 12-bit Wideband IF Digitizer, and details the procedure used to replace a faulty unit.

Replacement Parts

The following replacement parts are available for the M9202A PXI Express 12-bit Wideband IF Digitizer.

Module Core Replacement

Ordering a core replacement module

- 1. Contact Agilent (see www.agilent.com/find/assist).
- 2. Order a replacement core kit for your module (refer to the parts list in this section).
- 3. When you receive the replacement core kit, it will comprise:
 - An Entitlement Certificate.
 - Replacement module, with a Calibration certificate.
 - A 'Defective Return' sticker and return instructions.

Replacing the defective module

CAUTION Before opening a packaged module, ensure that all necessary ESD precautions are observed.

1. Write down the serial number of the defective module (shown on the side cover plate). This serial number will be assigned later to the replacement module later in this procedure.

- 2. Remove the plate containing the serial number from the defective module, by removing the 2 screws shown using a Torx[™] T8 screwdriver.
- 3. Remove the serial number plate from the replacement module, also using a TorxTM T8 screwdriver.

- 4. Attach the plate from the defective module to the replacement module, tightening the screws to **0.5** Nm. Note that the kit contains 2 extra screws which may be used if the original ones have been lost or damaged.
- 5. Attach the plate from the replacement module to the defective module, tightening to **0.5** Nm.
- 6. Install the replacement module into the chassis (see "Section 1 Getting Started" on page 7)
- 7. Power-up the chassis. (If you are using a remote controller, also power-up the computer).
- 8. Install the required Utilities. If you have already installed the following items on your computer, you may skip to step 9.
 - a. **The MD1 Digitizer Instrument Driver** (release 10.0 or higher) is required to perform this operation, please install it from the Product CD (M9210-90007) or download it from the Agilent website at: www.agilent.com/find/drivers and search for 'MD1'.
 - b. The Agilent Licence Manager (ALM) application is also required to perform the assignment of the serial number. Download and install ALM from www.agilent.com/find/licensemanager. Instructions on the installation & use may also be found from that web page.
 - c. Navigate to the folder c:\program files(x86)\Agilent/MD1/bin/, and run the file named "CdfCore.msi". Follow the on-screen instructions, select a 'complete' installation, and wait for the installer to finish.
- 9. Run the Agilent Licence Manager utility:
 - a. From the windows *Start Menu > All Programs > Agilent Licence Manager > Agilent Licence Manager*. The ALM window will appear. Note that you may or may not have licenses already listed depending on whether you have used the utility before.

- b. On the right of the item 'Host ID', Press the 'Copy' button.
- 10. Run the MD1 Serial Number utility:
 - a. Navigate to the folder c:\program files(x86)\Agilent\MD1\bin\, and run the file named "MD1Serial.exe"
 - b. A dialog window will open asking for the Host ID. Paste the previously copied ID into this window and press 'OK'
 - c. Select the replacement module (serial number starting '41xxxxxxx')

NOTE If a message is displayed at this point saying "No core replacement modules found" please check that the module is correctly installed, and that the serial number starts with '41xxxxxxx'. For assistance contact support at: acqiris_support@agilent.com

- d. Enter the serial number of the defective unit that you have written down in step 1), and press return.
- 11. Use the Agilent Software Manager to obtain a new license:
 - a. Access the Agilent Software Manager at: <u>www.agilent.com/find/softwaremanager</u>. If you have already registered here, please log in as a 'Returning User'. Otherwise complete the registration process by clicking on the 'Register' option.
 - b. The first screen will appear as shown below. Again, it may or may not have any licenses listed depending on whether you have already used this procedure.

- c. Click on the 'Get a license' or 'Get more licenses' link.
- d. If you have already registered an Entitlement Certificate which still has available licenses, you will be shown a list of the available licenses. You may jump to step f).

15. At this point the core replacement has been completed, but the module will only have the base options installed. The utility will generate an email which must be sent to Agilent support (acqiris support@agilent.com).

Restoring the original instrument options

A module which has been replaced with a new core will only have the base level of options installed initially. Since it is not possible to read these options from the defective module to transfer them directly, they must be restored with the following procedure.

- 1. In the previous step the MD1 Serial Number Update Utilty will have generated an email to Agilent support and requested that you send it. If for any reason this was not sent, you may send an email manually. It must contain the following information:
 - The serial number of the defective module ('USxxxxxxx')
 - The serial number of the core replacement module ('41xxxxxxx')
 - The name and email address (if different) of the owner of the module.
- 2. Once the correct options have been checked against your original (and any upgrade) order, Agilent support staff will generate and send by email a new options file, along with the necessary tools and instructions to perform the restoration.

NOTE

Since the options must be checked an generated by Agilent support personnel there may be a delay of up to 2 working days before you receive this email. If you have not received any email after this time, please contact Agilent support at acqiris_support@agilent.com.

Return the defective module

- 1. Review the warranty information supplied with your product.
- 2. Take the supplied Defect label and fill out the details, including the Fault Description from the TME Test Report, and stick it onto the defective module.

- 3. Include with the module a printed copy of the TME test results (Failure).
- 4. Pack the module in its original ESD bag and packing carton. If the original carton is not available use bubble wrap and place the unit in a sealed container. Mark the carton as 'Fragile'.
- 5. On the shipping label, write 'Attention Repair Department' and the RMA number.

NOTE

In any correspondence always include the product model and serial numbers.

Appendix - M9202A Reference Information

This section is intended to provide general information, links to specifications and information on the M9202A PXI Express 12-bit Wideband IF Digitizer.

M9202A Overview

The M9202A is a one-slot 3U PXIe Wideband IF Digitizer running at 2 GS/s, with up to 1 GHz instantaneous analog bandwidth and providing a large 512 MB DDR3 memory. The M9202A features a Xilinx Virtex-6 FPGA that can implement different functions depending on which firmware option is chosen.

The -BAS option provides basic digitizer functionality allowing capture of a signal, storing of data in the memory and/or transferring it via PXIe for example. The -DDC option, in addition to basic digitizer functionality, implements a Digital Down-Conversion (DDC) algorithm in the 300 MHz to 700 MHz band, improving the analog performance - the Spurious Free Dynamic Range (SFDR) or Signal-to-Noise Ratio (SNR) and reducing data upload time.

Key Features:

- 2 GS/s sampling rate
- Up to 1 GHz bandwidth
- SFDR = 60 dBc (typ.) in basic digitizer mode
- SFDR = 84 dBc (typ.) after digital down-conversion (with DDC option)
- AC-coupled 50 Ω input impedance
- +4 dBm full scale range (dither disabled)
- 512 MB DDR3 Memory

Front-end and ADC

The M9202A features a single channel ADC which digitizes the 50 Ω AC-coupled analog input at a fixed sampling rate of 2 GS/s. The ADC also accepts an external clock input which may be selected by the user.

External Clock (CLK IN)

The External Clock may be used, it must be continuously present if selected for the digitizer to operate correctly. The input is 50 Ω , AC coupled.

Timebase block

The timebase block accepts the multiple trigger inputs as well as providing one user-selectable trigger output and an External Reference input. A crystal-controlled timebase is used to clock the ADC system of the digitizers, with accuracy guaranteed to be better than 2 ppm. The digitizers also measure the time from the trigger point to the first sample point. Thus the trigger event can be positioned accurately to the sampled signal.

Trigger Sources

The trigger source can be a signal applied to one of the External Trigger Inputs. These inputs provide fully functional trigger circuits with selectable level and slope. The external trigger circuit has diode protection against overload. A ± 5 V limit on trigger signals should be respected, although somewhat higher voltages for short time periods will not damage the unit. The M9202A has a fixed 50 Ω termination impedance with DC coupling.

External Reference (REF IN)

For applications that require greater timing precision and long-term stability than is obtainable from the internal clock, a 100 MHz Reference signal can be used. The External Reference is nominally at 100 MHz. However, frequencies in a range will be accepted.

If your input is not at exactly 100 MHz, you must remember to compensate for the difference in your application since the digitizer and the driver have no way to know about such deviations.

If synchronization between several digitizers is required, the reference signal should be applied to all of them.

FPGA and Memory

The core data processing is performed in a Xilinx Virtex-6 FPGA, allowing different functionalities to be implemented in firmware. 512 MB of DDR3 memory is installed, and this is used for acquisition storage holding a maximum of 256 M samples.

DDC option

Where installed as an option the FPGA also performs Digital Down Conversion, such that the digitizer may function as the Intermediate Frequency (IF) digitization element in a digital receiver.
