This upgrade adds Option H01 to the network analyzer. Depending on the network analyzer model, there are two or three new synthesizer boards that must be installed, replacing the original boards. To learn which boards to order, refer to "Ordering the New Synthesizer Boards From Keysight" on page 6.

# **Ordering the New Synthesizer Boards From Keysight**

### Verify the Part Number(s) and Quantities of the Existing Synthesizer Boards in the PNA

- **NOTE** In the two steps below, you are instructed to note which boards (and their part numbers) are installed in your analyzer, to help determine the replacement boards that you will order. If your analyzer model is the N5222/4/5/7A or N5247A, you do not need to note each board P/N because you will order only the N5242-60071 replacement boards.
- 1. On the PNA, select System, Service, Utilities, View EEPROM Headers. Refer to Figure 1.
- 2. In the EEPROM Header Info dialog window:
  - a. Click LO Synthesizer, and note the board P/N (part number).
  - b. Click **Src2 Synth**, and note the board P/N, if any. This board may not be included in the PNA, depending on the options installed.
  - c. Click Src1 Synth, and note the board P/N.

#### **Order the New Synthesizer Boards**

- 1. If your network analyzer has synthesizer boards with part number N5242-63150, or if your analyzer model is the N5222/4/5/7A or N5247A, order the new replacement board part number N5242-60071. These boards have tabs or "ears" that allow them to be secured with screws to the analyzer chassis.
- If your network analyzer has synthesizer boards with part number N5242-63166, or N5230-63002, or N5230-60002, order the new replacement board part number N5242-60072. These boards do not have tabs or "ears."

NOTE	If the PNA already contains N5242-60071 or N5242-60072 boards, they do not need to be
	replaced.

#### **Request an H01 Label for the PNA Rear Panel**

You must request an adhesive H01 label – as shown in the photo below – from CTD Support by sending an email including your name and mailing address to *ctd-soco\_support@keysight.com*. In the subject line of the email, type "H01 Label." The label is to be attached on the PNA rear panel to indicate the H01 upgrade has been performed.



# Installation Procedure for the Upgrade

The network analyzer must be in proper working condition prior to installing this option. Any necessary repairs must be made before proceeding with this installation.

# WARNING This installation requires the removal of the analyzer's protective outer covers. The analyzer must be powered down and disconnected from the mains supply before performing this procedure.

#### Step 1. Replace the Existing Synthesizer Boards with the New Synthesizer Boards

The following instructions are abbreviated for the purpose of this document, but illustrations and the details of each instruction are available in your PNA Service Guide's chapter 7 - see "Downloading the Online PNA Service Guide" on page 4.

NOTE	Leave the gray flexible cables, the wire harnesses, and the ribbon cables connected where possible. <b>Any that are removed should be labeled for reconnection later.</b>
CAUTION	Be careful not to damage the center pins of the semirigid cables. Some flexing of the cables may be necessary but do not over-bend them.

- Remove the outer cover.
- Remove the inner cover.
- Remove and replace the existing 13.5 GHz (source 1) synthesizer board (replace with either the N5242-60071 or N5242-60072, depending on what you ordered).
- Remove and replace the existing 13.5 GHz (LO) synthesizer board (replace with either the N5242-60071 or N5242-60072, depending on what you ordered).
- If necessary, remove and replace the existing 13.5 GHz (source 2) synthesizer board (replace with either the N5242-60071 or N5242-60072, depending on what you ordered). This board may not be included in the PNA, depending on the options installed.
- Reinstall the inner cover.
- Reinstall the outer cover.

# Step 2. Install Adhesive Label on Rear Panel

On the previous page of this document, you were instructed to request an adhesive H01 label from CTD Support. Attach this label to the PNA rear panel, next to the instrument serial number label.

#### Step 3. If Necessary, Download PNA Firmware

For the new N5242-60072 boards to function properly in your PNA, you must upgrade your PNA firmware to rev A09.33.00 or above. Download PNA firmware at: http://na.support.keysight.com/pna/firmware/firmware.html.

#### Step 4. Perform Post-Upgrade Adjustments and Calibration

**NOTE** The analyzer may display error messages when first powered on. Adjustments and normal operation should clear the error messages.

#### Adjustments

The following adjustments must be made due to the hardware changes of the analyzer.

- synthesizer bandwidth adjustment
- EE default adjustment (initialization only)
- source adjustment
- · receiver adjustment

These adjustments are described in the PNA Service Guide and in the PNA on-line HELP. A list of equipment required to perform these adjustments is found in the PNA Service Guide.

After the specified adjustments have been performed, the analyzer should operate and phase lock over its entire frequency range.

#### **Operator's Check**

Perform the Operator's Check to check the basic functionality of the analyzer. For instructions, click the Chapter 3 bookmark "Tests and Adjustments" in the PDF Service Guide<sup>1</sup>.

#### **Performance Tests**

Perform the following tests using TME based test software or using the analyzer's internal performance test software:

- Source Power Linearity Test
- Source Maximum Power Test
- Trace Noise Test

#### Step 5. Prepare the PNA for the User

- 1. If necessary, reinstall the dust caps on the test ports.
- 2. Clean the analyzer, as needed, using a damp cloth.
